

**WARRANT TO CALL  
MAINE SCHOOL ADMINISTRATIVE DISTRICT NO. 72  
BUDGET MEETING  
(20-A M.R.S. § 1485)**

TO: Holly Foster, a resident of Maine School Administrative District No. 72 (the "District") composed of the Towns of Brownfield, Denmark, Fryeburg, Lovell, Stoneham, Stow and Sweden, State of Maine.

In the name of the State of Maine, you are hereby required to notify the voters of each of the municipalities within Maine School Administrative District No. 72, namely, the Towns of Brownfield, Denmark, Fryeburg, Lovell, Stoneham, Stow and Sweden, that a District Budget Meeting will be held at Molly Ockett Middle School, Molly Ockett Drive in Fryeburg, Maine at 7:00 P.M. on May 29, 2013 for the purpose of determining the Budget Meeting articles set forth below.

**ARTICLE 1A:** To elect a moderator to preside at the meeting.

**ARTICLE 1:** To see if the legislative body of the District (i.e. the voters of the District assembled at a meeting) will vote to authorize the school board for FY 2013-2014 to pay Fryeburg Academy an insured value factor of 10% of Fryeburg Academy's tuition rate per student rather than a lesser amount as described below, where the applicable education laws provide that:

1. The District is not required to pay an insured value factor greater than 5% of Fryeburg Academy's tuition rate or \$500 per student, whichever is less, unless the legislative body of the District (i.e. the voters of the District assembled at a meeting) votes to authorize its school board to pay a higher insured value factor; and
2. Any amount paid by the District for insured value factor above 5% of Fryeburg Academy's tuition rate or \$500 per student whichever is less, is not eligible for inclusion in the District's debt service allocation for purposes of calculating state school subsidy to the District.

**ARTICLE 13:** To see what sum the District will appropriate for the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act and to see what sum the District will raise and assess as each municipality's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act in accordance with the Maine Revised Statutes, Title 20-A, section 15688. **Recommended amounts set forth below:**

*Explanation: The District's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act is the amount of money determined by state law to be the minimum amount that the District must raise and assess in order to receive the full amount of state dollars.*

**ARTICLE 14:** (Written ballot required). To see what sum the District will raise and appropriate in additional local funds (**Recommend \$2,450,974.00**), which exceeds the State's Essential Programs and Services allocation model by (**Recommend \$2,184,975.94**) as required to fund the budget recommended by the School Board

The School Board recommends \$2,450,974.00 for additional local funds and gives the following reasons for exceeding the State's Essential Programs and Services funding model by \$2,184,975.94: The District has higher secondary private tuition costs than are recognized by the Essential Programs and Services funding model. The District also has higher special education costs than are recognized by the model, and due to the geographical size of the District, smaller class sizes and higher transportation costs than are recognized by the model.

*Explanation: The additional local funds are those locally raised funds over and above the District's local contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act and local amounts raised for the annual payment on non-state funded debt service that will help achieve the District budget for educational programs.*

#### **ARTICLE 15 SUMMARIZES THE PROPOSED SCHOOL BUDGET**

**ARTICLE 15:** To see what sum the District will authorize the School Board to expend for the fiscal year beginning July 1, 2013 and ending June 30, 2014 from the District's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act, non-state-funded school construction projects, additional local funds for school purposes under the Maine Revised Statutes, Title 20-A, section 15690, unexpended balances, tuition receipts, state subsidy and other receipts for the support of schools.

#### **ARTICLE 16 AUTHORIZES EXPENDITURE OF GRANTS AND OTHER RECEIPTS**

**ARTICLE 16:** In addition to amounts approved in the preceding articles, shall the School Board be authorized to expend such other sums as may be received from federal or state grants or programs or other sources during the fiscal year for school purposes, provided that such grants, programs or other sources do not require the expenditure of other funds not previously appropriated?

#### **ARTICLE 17 AUTHORIZES THE ADULT EDUCATION PROGRAM AND RAISES THE LOCAL SHARE**

**ARTICLE 17:** To see if Maine School Administrative District No. 72 will appropriate \$575,917 for adult education and raise \$12,000 as the local share; with authorization to expend any additional, incidental, or miscellaneous receipts in the interest and for the well-being of the adult education program.

**ARTICLE 18 AUTHORIZES THE USE OF UP TO \$266,312 FROM THE CAPITAL RESERVE ACCOUNT FOR THE SNOW SCHOOL CONSTRUCTION PROJECT AND SECURITY AND SAFETY UPGRADES AND OTHER MINOR CAPITAL PROJECTS**

**ARTICLE 18:** Shall the School Board be authorized to expend up to \$266,312 from the District's capital reserve fund previously established by the District voters for the purpose of school construction and minor capital projects in the District including the following: (i) architect fees and other preliminary costs related to the Snow School Construction project, (ii) security and safety upgrades at District schools and (iii) other minor capital projects at District schools?
